

[Important] Electronic registration form for PCR test upon arrival at Manila Ninoy Aquino International Airport (MNL)

Due to the evolving COVID-19 situation, PAL and the Philippine Government have issued precautionary measures, mandatory protocols, and requirements for travelers. Here's how to ensure a smooth travel to the Philippines.

This procedure is required for all passengers boarding international flights to Manila before arriving at the airport (Japan).

How to proceed with the electronic registration form

BEFORE YOU FLY AND DURING CHECK-IN

1. You can access it from the following URL or QR code.

● Non-OFWs and foreign nationals "PALeCIF (ONE-STOP-SHOP) registration"

* You can complete the procedure from **3 days before** the flight.



✂ For non-OFWs, ensure to have a confirmed booking at a hotel accredited by Tourism and Health Agencies while waiting for your COVID-19 test results and for at least 2 days.

Upon check-in, sign the Declaration and Waiver Form presented by our check-in agent, indicating that you are healthy and fit to travel.

● Overseas Filipino Worker (OFW): "Registration of Redcross" and "Registration of OASIS"

* You can complete the procedure from **3 days before** the flight.

For All OFW passengers needs to perform the OASIS (Land or sea): <http://oasis.owwa.gov.ph/>

* Please complete the procedure at least **5 days before** your flight.

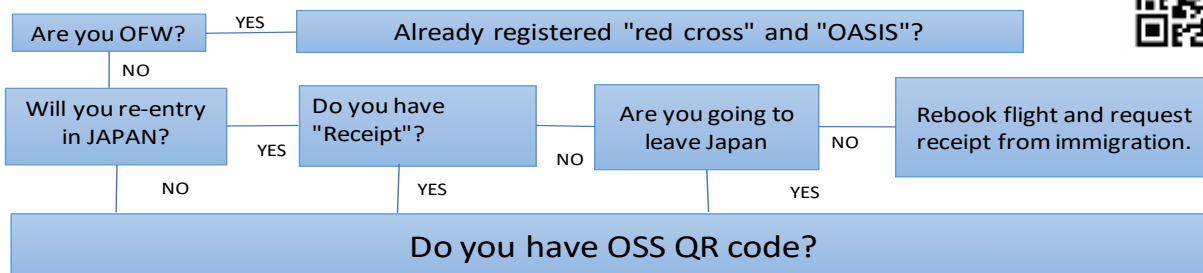


2. After completing the registration of the electronic registration form, please save the confirmation email and QR code and bring it with you so that you can present it at any time when you arrive at Manila Airport.

3. After checking in online or at the airport, accomplish the Electronic Health Locator Form and Arrival Card at <https://bit.ly/MNLArrivalCard> and save the QR code for presentation to the Immigration Officer upon your arrival.

Precautions

Please note that after completing the electronic registration procedure, you will need to complete the procedure again if any of the following reasons apply.

- ★ When there is a change in health
- ★ An Overseas Filipino Worker (OFW) is a person from the Philippines who usually lives and works temporarily in another country. This includes land OFWs and seafarers / sea OFWs. Families traveling with at least one OFW are considered all OFWs.
- ★ Non-OFW refers to Filipinos returning home (students other than OFW, Balikbayan other than OFW, tourists other than OFW, etc.), Filipino spouses and children, diplomats, Filipino-certified foreign civil servants, qualified non-Philippines. People / foreigners Citizens with long-term visas.
